PUBLIC CONSULTATION MEETING

NOTICE TO THE TAXPAYERS OF THE MUNICIPALITY IS HEREBY GIVEN BY THE UNDERSIGNED THAT

1. During the meeting held on February 14, 2023, the council adopted the **first draft by-law** number RU-951-02-2023, modifying the zoning by-law number RU-902-01-2015, which is described as follows:

Draft by-law number RU-951-02-2023, amending zoning by-law number RU-902-01-2015, as amended, in order to add and modify certain provisions concerning short-term rental

The purpose of the draft by-law is to replace the definition of *tourist accommodation establishment* with a new definition, to add a new definition of *principal residence establishment*, to add a new definition of *youth accommodation*, to add a new definition of *general tourist accommodation establishment* and to replace the definition of *tourist residence* with a new definition.

The purpose of the draft by-law is to authorize, subject to certain conditions, the use of a tourist residence as an additional use for detached single-family dwellings within the following zones:

RU-01, RU-02, RU-03, RU-04, RU-05, RU-06, RU-07, RU-08, RU-09, RU-10, RU-11, RU-12, RU-13, RU-14, RU-15, RU-16, RU-17, RU-18, V-01, V-02, V-03, V-04, V-05, V-06, V-07, V-08, V-09, V-10, V-11, V-12, V-13, V-14, RV-01, RV-02, RV-03, RV-04, RT-01, RT-02, RT-03, RT-04, RT-05, RT-07, UI-01, PL-01, UL-01

The purpose of the draft by-law is to authorize, subject to compliance with certain conditions, the new use of a principal residence establishment within the following zones:

RU-01, RU-02, RU-03, RU-04, RU-05, RU-06, RU-07, RU-08, RU-09, RU-10, RU-11, RU-12, RU-13, RU-14, RU-15, RU-16, RU-17, RU-18, V-01, V-02, V-03, V-04, V-05, V-06, V-07, V-08, V-09, V-10, V-11, V-12, V-13, V-14, RV-01, RV-02, RV-03, RV-04, RT-01, RT-02, RT-03, RT-04, RT-05, RT-07, UI-01, PL-01, UL-01

- 2. A public consultation meeting will be held on **Thursday, March 9, 2023, at 6:00 p.m.**, at 88 des Érables street, in Grenville-sur-la-Rouge. The purpose of the meeting is to hear from individuals and organizations who wish to express their views on the proposed by-law. During this public meeting, the draft by-law will be explained as well as the consequences of its adoption.
- 3. The draft by-law may be consulted at City Hall, 88 Des Érables Street, during office hours.
- 4. This draft by-law is subject to referendum approval by persons entitled to vote under the Planning and Development Act.
- 5. The plan showing the affected areas can be viewed at the municipal office during regular business hours.
